2. Available Feature Package Components - Continued

3. Conditions of Service

1. The Feature Package is available only to residential or single-line business customers.
2. Customers subscribing to the Feature Package may choose less components than the Feature Package allows for, however, the full Feature Package price applies.
3. Residential Voice Mail is available only to residential customers. C
4. Business Voice Mail is available to both residential and single-line business customers. C
5. Rotary dial customers are not eligible.
6. All services within the Feature Package are provided subject to the availability of suitable facilities and equipment.
7. The SmartTouch Subscription Services and/or SaskTel Voice Mail Service that are specified above can not be combined with any other SaskTel SmartTouch Subscription Services and/or SaskTel Voice Mail Service promotional offers involving the same components. C
8. Customers who move subsequent to enrolling in the Feature Package may continue subject to the availability of the components in their new exchange.
9. Customers can subscribe to a maximum of three Ident-A-Call numbers or three Data Ident-A-Call numbers. However, each Ident-A-Call number and/or Data Ident-A-Call number is equivalent to one component within the Feature Package.
10. Customers must enroll to be eligible.
11. Customers may change their choice of components at any time for no additional charge.
12. Customers can only subscribe to one Feature Package per telephone number.
