



SaskTel Stores Christmas \$500 Store Gift Card Contest - 2019

Rules

The contest:

- The \$500 SaskTel Store Gift Card Contest will run from November 26, 2019 until December 31, 2019 ("Contest Period"). All customers are able to complete an entry ballot in a SaskTel Store during the Contest time frame (please see "How to Enter" below).
- All contest entries must be received by December 31, 2019 at 11:59 pm CST. SaskTel accepts no responsibility and will not be liable for entries that are not received, incomplete, lost, late, misdirected or illegible for whatever reason, including without limitation, due to computer or network or other system interruption, malfunction, failure or breakdown of any kind or duration. SaskTel reserves the right in its absolute discretion, without any liability to any Contest entrant, to withdraw or modify the Contest should any of SaskTel's systems or its network be adversely affected by any virus or other similar destructive agent during the Contest Period.
- SaskTel will make a random draw from all eligible entries received in each SaskTel Store. To be declared a winner the selected entrant must successfully answer a skill testing question. The Contest winners will be selected on or about January 13, 2020 in Regina. Chances of winning are dependent upon the number of eligible entries received.
- The Contest is subject to all applicable federal and provincial laws.
- SaskTel shall be the sole judge and decision maker regarding any dispute regarding the application or interpretation of the Contest Rules or any other aspect of the Contest and SaskTel's judgment or decision shall be final.
- SaskTel retains the right in its sole and absolute discretion, to suspend or change for any reason, the start and/or end dates of the Contest, or to modify, suspend or cancel the Contest in part or as a whole for any reason.
- SaskTel reserves the right in its sole discretion to disqualify any individual from the Contest and to ban that individual from any future SaskTel contest who it finds or believes to be tampering with the Contest entry process, the operation of the Contest or is acting in violation of the Contest rules.
- SaskTel is the sole sponsor of this Contest.

How to enter:

Contest entrants can enter the following way:

- All customers are able to complete an entry ballot in a SaskTel Store between November 26 and December 31, 2019.

Entry deadline: December 31, 2019 at 11:59 pm CST.



Eligibility:

- The Contest is open to Saskatchewan residents only who are at least 18 years of age and who complete an entry ballot in a SaskTel Store during the Contest Period. If you are a SaskTel customer and you are chosen as a potential winner, in order to be eligible to win, your SaskTel account must be in good standing at the time of the draw. "In good standing" means a customer who has an account with SaskTel as of the draw date and whose account balance is not outstanding over 59 days or suspended for non-payment.
- An entrant selected as the winner in the Contest draw at one SaskTel Store is not eligible to be selected as the winner in the Contest draw at any other SaskTel Store location

The following persons are not eligible to enter the Contest:

- Employees of SaskTel, its parent corporation or its affiliates and their immediate families (or persons with whom they are domiciled); or
- Any SaskTel dealer or dealer employees and their immediate families (or persons with whom they are domiciled).

Prizes:
