1. Service Description

Voice Grade Facilities – Local are communication paths with the bandwidth to carry telephone speech (or its equivalent).

These Voice Grade facilities:

- (a) extend from SaskTel's central office(s) to the SaskTel network interface demarcation point.
- (b) do not provide a direct connection to SaskTel's public switched telephone network (PSTN).

2. Conditions of Service

- 1. SaskTel does not guarantee DC (Direct Current) continuity. The provisioning of metallic or DC continuity is provided only where metallic facilities currently exist.
- 2. Rates and charges for legs and/or the portion of the leg that extends beyond the base rate / island base rate area are *in addition* to the rates and charges for the main channel.

- 3. The monthly rental for the portion of the leg that extends beyond the base rate / island base rate is for each 1/4 mile (402.32 metres) or fraction thereof, that the service is from the nearest point on the nearest base rate / island base rate area boundary.
- 4. Extra provisioning charges may apply. Refer to the item on Extra Provisioning Charges.
- 5. Service charges depend on whether or not a field visit is required.
- 6. Voice grade facilities are provided "as is". If the cable pair is in a facility that has been loaded by SaskTel, and the customer requests the loading removed, the customer is charged the full cost of this work. Special Facilities procedures may apply.
- 7. If signaling conversion is required at either or both ends of the circuit, it may be provided by a Special Facility Tariff.
- 8. This service is no longer available for new installations, additions to existing installations or moves and rearrangements on the same or different premises.
