<u>PUBLIC REPORT</u> PURSUANT TO THE JUDGMENT DATED JULY 9, 2024

STATEMENT OF ISSUE(S)

One Key Issue: **Review and verify** the application of the criteria by the Applicants' Agent for the identification of IP addresses for blocking, and criteria applied that resulted in them being notified for blocking;

INTRODUCTION AND SUMMARY

1) We were able to review and independently verify the criteria used by FMTS to select IP addresses for inclusion in the blocklist from July 2024 to June 2025. The IP addresses associated with the distribution of the following sports content were included in the blocklists: National Hockey League (NHL), International Ice Hockey Federation World Junior Championships (IIHF), National Basketball Association (NBA), Premier League (PL), Ultimate Fighting Championship (UFC), Major League Baseball (MLB), and UEFA Europa League (UEFA). We confirmed that 8,970 unique IP addresses were valid matches.

OUALIFICATIONS

- 2) I am a partner at the Toronto, Ontario, law firm of Lipkus Law LLP. The principal focus of my practice is in the area of intellectual property.
- I received my Juris Doctor from the University Of Detroit Mercy School Of Law in 2008. I received a BA in Honours Philosophy: Reasoning and Ethics in 2005 from The University of Western Ontario. I became a member of the New York State Bar in March, 2009. I was called to the Ontario Bar in January, 2010.
- 4) I have conducted training sessions, workshops and lectures on intellectual property enforcement for various regional, municipal and Federal police forces, representatives of Canada Border Services Agency, private investigators, and various professional organizations.

- I have also regularly attended lectures, seminars and conferences on a variety of counterfeiting issues conducted by our firm and various intellectual property rights holders, including the International Anti-Counterfeiting Coalition (IACC), the largest international organization devoted solely to combating product counterfeiting and piracy and the International Trademark Association.
- 6) I regularly review jurisprudential developments in the field of Anton Piller Orders, and I am very much aware of the jurisprudence of this Honourable Court on Anton Piller Orders. I am mindful of the importance of respecting the rights of the person(s) on which an Anton Piller Order is executed including third parties in attendance during the execution of an Anton Piller Order, and take my responsibilities as an officer of the court in this regard very seriously.
- 7) I have executed several Anton Piller Orders granted by this Honourable Court and the Superior Court of Justice in Ontario as an independent supervising solicitor.
- 8) My work as an independent supervising solicitor in the *Tracey Clancey et al v. Tanvir Farid* matter (file number CV-17-587516) was commented on by the Honourable Justice Pattillo at paragraph 36 of his endorsement:
- "I am satisfied, based on the material filed, that the APO was conducted in accordance with the terms of both the APO/Injunction Order and the December 11, 2017 Order extending it. I find that at all material times, the ISS and those accompanying him as authorized by the APO acted in both a courteous and professional manner at all times towards Farid."
- On behalf of my clients, I am involved with the removal of tens of thousands of online listings that include infringing content. I have been provided with access to (and utilization of) numerous third-party provider software, to assist with these intellectual property takedowns efforts. Additionally, I regularly review the policies of Registries, Registrars, ISPs, social media platforms, marketplaces and other intermediaries as it relates to intellectual property infringement.
- 10) Attached hereto and marked as Schedule A is a copy of my Curriculum Vitae including my rankings, speaking engagements, publications and memberships.

DISCUSSION

Review and verify the application of the criteria by the Applicant's Agent for the identification of IP addresses for blocking:

11. The Applicants' Agent (Friend MTS Limited (" FMTS ") searches for and

Review and Verification:

To facilitate our review and verification of the criteria for identifying IP addresses for blocking (including its application of the criteria set out in Confidential Schedule 2), FMTS provided us with spreadsheets containing all IP addresses on the blocklists, and timestamps indicating when they were added to the blocklist, among other things. In total, 593,801 IP addresses were added to the blocklists from July 2024 to June 2025. The information and documentation will remain on FMTS' portal for at least one year, and will be accessible to us in the event we are required to produce any additional information concerning our review and verification.

Breakdown of IP addresses/Media Segments Provided by FMTS:

When verifying these criteria, we used sample sets of unique IP addresses. These unique IP addresses were obtained by removing duplicate occurrences of IP addresses from the blocklists, leaving only the unique IP addresses per rights owner. In total, there were 44,966 instances where the IP addresses were verified and confirmed to meet blocking criteria (A breakdown chart can be seen in section 25). The 44,966 instances were further refined to identify the number of unique IP addresses across all rights owners, resulting in a total sample of 8,976 unique IP addresses.

Time Limits

Pursuant to the terms of the Judgment, IP addresses added to the blocklist are those determined by FMTS to be part of streaming infrastructure making the Protected Live Content available without authorization during the NHL, IIHF, NBA, PL, UFC, MLB, and UEFA Protected Live Content Windows, as well as during the Pre-Monitoring Period.

Verification:

18) Reviewing the blocklist, we confirmed that all 8,976 unique IP addresses were added to the blocklist during the NHL, IIHF, NBA, PL, UFC, MLB, and UEFA Protected Live Content Windows, as well as during the Pre-Monitoring Period.

/Proprietary Technology

technology which allows it to compare available content to legitimate samples of NHL, IIHF, NBA, PL, UFC, MLB, and UEFA live sports events (referred to herein as "**Protected Live Content**"). When matches are detected, the IP addresses of the source and associated streaming infrastructure are flagged for potential inclusion in the blocklist. Screenshots and video footage of the matched content are retained and were made available, along with thumbnail images of the identified content and the legitimate sample content it was found to match.

Verification

- 20) To verify that the Protected Live Content was properly identified, we reviewed all matches that resulted in blocklist entries for the 8,976 unique IP addresses. Only blocklist entries added during the Pre-Monitoring Period and Protected Live Content Windows were reviewed. Some of the 8,976 unique IP addresses were found to be associated with multiple matches throughout the Pre-Monitoring Period and Protected Live Content Windows. In total, the selection included 44,966 instances of IP addresses confirmed to meet blocking criteria, corresponding to the 8,976 unique IP addresses.
- 21) Our validity checking involved visual review of thumbnail images, screenshots, and video captured from online video streams for each, and comparing them to reference images of the Protected Live Content this streaming content was matched against.

 , and comparing them to reference images of the Protected Live Content this streaming content was matched against. The total count of 1,608 was refined to display unique IP addresses associated with

 across all rights owners, resulting in a total of 753 verified unique IP addresses.
- Captured thumbnail images and video content for four matches (three on August 18, 2024, and one on August 19, 2024) did not appear to relate to Protected Live Content. FMTS indicated that this was due to a hardware configuration issue associated with an ingested The Sports Network Inc. (TSN) channel in a period where no TSN content was covered by the Judgment, causing the process to match content not covered by the Judgment. These IP addresses should not have been included in the blocklist. An additional two matches resulted in the following errors: "No Records Found" and "No Image Available". We were unable to verify these matches through manual, visual

verification of Protected Live Content. The issue was brought to the attention of FMTS. As a result, FMTS advised that the error was a result of an issue with data retention for these incidents, and they were no longer able to provide data for these entries. For this reason, these 2 IP addresses could not be verified.

24) We confirmed that 8,970 unique IP addresses were valid matches.
