2015 Student Campaign Free Tuition Promotion Official Rules

- 1. The 2015 Student Campaign Free Tuition Promotion runs from July 1, 2015 to October 18, 2015 ("Promotion Period").
- All entries must be received before the end of the Promotion Period being October 18th, 2015 at 11:59 pm. SaskTel accepts no responsibility and will not be liable for entries that are not received, incomplete, lost, late, or misdirected for whatever reason.
- 3. SaskTel will make a random draw on or about October 19th, 2015 from all eligible entries received for the prizes. Chances of winning are dependent on the number of eligible entries received. Chosen entrants must correctly answer a time limited mathematical skill testing question before being declared a winner.
- 4. This Promotion is subject to all applicable federal and provincial laws.
- 5. SaskTel is the sole judge and decision maker regarding any dispute about the application or interpretation of the Rules or any other aspect of the Promotion and the judgment or decision of SaskTel shall be final.

How to enter

Each entrant subscribing to SaskTel infiNET High Speed Mach 1 or High Speed Ultra Internet Service, maxTV[™] Basic Service or an applicable SaskTel Wireless rate plan (Ultimate 70, Ultimate 13th Man or Ultimate 100) before the Promotion Closing Date of October 18, 2015 will automatically receive an entry for each such SaskTel service the entrant subscribes to. Each entrant can qualify for a maximum of three (3) entries.

Eligibility

- 1. This Contest is only open to Saskatchewan residents who are 18 years of age or older and who are currently enrolled and taking classes at a post secondary education facility in Saskatchewan except:
