Description

Excess Mileage Charges are assessed to various access services located outside base rate and island base rate areas.

Terms and Conditions

These terms, conditions and rates apply only to exchanges that are forborne from regulation, as identified on page 360, *Forborne Local Exchanges*. For all other locations, refer to the regulated General Tariff.

1. The chargeable distance is the airline map measurement that the service is from the nearest point on the nearest base rate area or island base rate area boundary within that exchange area.
2. Excess Mileage Charges will be capped at a maximum amount except in the following instance:
 - a) where network access service is being provided to a location where the Customer requested individual line service prior to the implementation of SaskTel's Individual Line Service program in that location.

Rates

Customers in forborne *residential local exchanges* and forborne *business local exchanges* shall pay to SaskTel the following rates and charges for Excess Mileage Charges. Such rates and charges are in addition to any other rates and charges that may be applicable.
