Background

Established as a Treasury Board Crown in 2002, the Saskatchewan Watershed Authority manages and enhances the province's water and watershed resources for the environmental, economic and social benefit of Saskatchewan residents. The Authority is responsible for the allocation of ground and surface water inventory, analysis of water sources and owns and operates 45 dams and 35 kilometres of conveyance channels in the province. They are also responsible for managing watershed and aquifer planning, developing partnerships and projects that help provide healthy watersheds and assessment and monitoring practices that ensure the protection and restoration of the province's water sources.

Challenge

While their previous phone system largely served its purpose, the Saskatchewan Watershed Authority decided that the time had come to examine other, more innovative solutions; and facility renovations provided an ideal catalyst. With a minimal IT staff, it was important to find a system that required little space and maintenance. A specific window of opportunity (the conversion was to take place during renovations) meant finding a solution that was easy to implement as well. Add to the mix a desire for long distance savings and the flexibility to accommodate growth, and after examining a variety of providers, their options appeared limited.

Solution

Having the system off-site also provides the added benefit of SaskTel professionals to perform updates and ensure the system is always running properly. The installation process was simple and straightforward. "SaskTel worked closely with us to complete the conversion during renovations, and to make sure the system met our needs," Anderson says.
