



ITEM Extended Data Access Charge 110.08

1. Service Description

Extended Data Access charge applies when data access services are extended beyond the base rate area or island base rate area.

2. Conditions of Service

- 1. Charges specified in this item are in addition to the charges specified in the Extra Provisioning Charges Item.
- 2. Unless specifically stated otherwise, customer quotes based on the charges in this item shall be valid for a period of 90 days following the date of such quote.
- 3. Monthly rental and service charges for each data access service are in addition to these one time charges to extend the data access or service beyond the base rate area or island base rate area.

Reference: Refer to the items related to each data access or service, for applicable rates and charges.

4. When the furnishing of service involves extraordinary expense, or if the access extension technology is not of a type specifically included in this item, and if SaskTel is prepared to offer the service, the customer will be assessed SaskTel's total expense.

2. Conditions of Service – Continued

- 5. If the customer's premises is within a Base Rate Area or an Island Base Rate Area and:
 - (a) That the location is NOT currently a designated serving area for the service in question and,
 - (b) SaskTel is technically capable of, and prepared to offer the service at the location in question,
 - (c) The customer will be required to cover SaskTel's total expense for whatever equipment and transmission facilities may be deployed in order that the service may be offered in the location in question.
- 6. Replacement of a data access service for which Extended Data Access Charges apply.

Where as the customer:

- (a) Is located outside of a Base Rate Area or an Island Base Rate Area, and
- (b) The customer has had in place within the last ten (10) days a working extended data access service, and
- (c) The Extended Data Access charges have been paid in the past, and
- (d) The replacement access service is at this same location, and
- (e) The replacement access service will use the identical access loop facilities and equipment as the service to be discontinued, and
- (f) No access extra construction work or spending is required to convert the discontinued access service to the replacement access service, and

2. Conditions of Service – Continued

- (g) The replacement data access service is of similar like and kind provided by SaskTel and/or another carrier, and
- (h) The customer understands and agrees to accept downtime in order to convert the extended data access service from the discontinued service provider to the replacement service provider, and
- (i) That this break in service will not be included in any service level guarantees or be compensated for in any other way.

Then the charge, as specified in this Tariff item, to extend data access service that would normally apply for the installation of the data service replacement, does not apply.

3. Rates

The customer shall pay to SaskTel the following rates and charges for Extended Data Access Charge. Such rates and charges are in addition to any other rates and charges that may be applicable.

The following rates and charges apply to Extended Data Access beyond the base rate area or island base rate area.
