Directory File Service

1. Service Description

Directory File Service provides Local Exchange Carriers (LEC), Wireless Service Providers, Interexchange Carriers, Alternative Operator Service Providers (AOSPs), and Independent Telephone Directory Publishers a machine-readable file on an exchange-level or on an NXX basis. The file contains non-confidential customer listing information for SaskTel's directory listed customers, and those intended to be listed, in SaskTel's directories. This listing information is provided to LEC's, Wireless Service Providers, Interexchange Carriers, and AOSPs solely for the purpose of providing directory assistance services, and to Independent Telephone Directory Publishers solely for the purpose of compiling, producing, publishing and distributing independent telephone directories.

DFS service is provided by SaskTel in accordance with the terms and conditions contained in the DFS Agreement, including the limitation of SaskTel's liability. The licensee accepts all the obligations of the licensee pursuant to the DFS Agreement.

2. Definitions

For the purpose of this Tariff Item:

"Telephone Directories" means a general compilation of non-confidential telephone service subscriber listings, in a particular geographic centre, for general distribution in either print or electronic formats for the Licensee's clients or customers. Telephone Directories may be organized by customer type (e.g. residential, business, government), geography, business category (for business listing information) and/or level of government (for government listing information), and sequenced by name, address or telephone number. Telephone Directories may not otherwise be customized (either individually or on a market segment basis) for the Licensee's clients or customers. Telephone Directories specifically exclude the compilation of marketing lists or other similar activities. The information provided in Telephone Directories excludes all chronological information associated with the listing (i.e. when the listing was produced, added or last updated). Telephone Directories excludes directories provided in electronic format where such directories enable a user to download, mine, share, extract or otherwise copy larger quantities of data.

2. **Definitions** – Continued

"Directory Assistance" means the provision of a single listing or limited set of listing information by means of the Licensee's directory information service, in response to a specific query or transaction from a user. The purpose of the Directory Assistance service is to find an individual listing that will provide the user with the information to complete a telephone call. Data mining, data sharing or any other activity resulting in the transfer of larger quantities of Listings to another party are strictly excluded from the definition of Directory Assistance. Directory Assistance also excludes the provision of chronological information associated with the listing (i.e. when the listing was produced, added or last updated) or a response to a query that is based on chronological information.

"Machine-Readable" refers to the output format for Directory Files Service which is provided only on PC diskette or CD ROM as prescribed by SaskTel.


"Master File" refers to the complete directory file updated monthly to reflect customer listing information as of the last business day of each month.

"Update File" refers to the current monthly file which contains only the changes to customer listing information, i.e., additions, revisions and deletions resulting from service order activity during the current monthly interval affecting the master file.

3. Conditions of Service

- 1. Applicants to Directory File Service must enter into a licensing agreement with SaskTel (the DFS Agreement) which, among other things, protects SaskTel's and its affiliates' copyright of listed information.
- 2. The Licensee shall not license, sub-license, share, sell, re-sell, rent, lease, charge, encumber, pledge or otherwise dispose of, deal with, use or copy SaskTel's BLIF in favor of any person, save expressly permitted in this tariff and the BLIF Agreement. The Licensee agrees to take all necessary steps to protect and safeguard the Listings from unauthorized disclosure.

3. Conditions of Service - Continued

3. In the event of a breach by the Licensee of the DFS Agreement or this tariff, SaskTel shall have the right to terminate DFS Service if the Licensee has failed to rectify the breach within (30) days of the receipt of a written notice to that effect sent by SaskTel to the Licensee. In the event of repeated breaches by the Licensee of the DFS Agreement, this tariff, or the applicable agreement or tariff for Basic Listings Interchange file (BLIF) – General Tariff Item NUMBER, SaskTel may discontinue providing BLIF and DFS service to the Licensee with 30 days notice and refuse future requests from the Licensee in writing at the time of each of the breaches and, in SaskTel's reasonable judgment, the Licensee has repeatedly breached the applicable tariff or agreement.

4. Listing information is provided:

- i) To independent telephone directory publishers on condition that the information be used solely for the purposes of publishing Telephone Directories, and
- ii) To Local Exchange Carriers (LECs), Wireless Service Providers, Alternate Operator Service Providers, and Interexchange Carriers on condition that the information be used solely for the purpose of providing Directory Assistance.
- 5. As an exception to Resale and Sharing, the listing information provided under the terms of this Item, may not be shared, resold rented, or otherwise disposed of to any third party.
- SaskTel is not liable for any inaccuracies in the Directory File content, fault in the information due to the medium in which its contained, its suitability for the use by the purchaser or its merchantability or use for a particular purpose.
- 7. As an exception to the Terms of Service, SaskTel is not liable for any damage suffered by a customer or any person by reason of, or further to, making customer listing information available to a third party in accordance with the application of this tariff item.
